1. The Energiebedrijven Suriname invites bids from eligible and qualified bidders for material supply and installation for the upgrade fire protection system at Ogane Nickerie. The delivery and construction period is 5 months from commencement of work.

- 2. The RFB will be conducted through Competitive Bidding and is open to all eligible bidders as defined in the bidding document.

- 4. Qualifications requirements include:
 - Completed at least two projects similar in nature in the past 5 years with a budget in excess of USD 300,000 or the equivalent in another currency.
 - *Qualified key personnel adhering to the following:*
 - 1. **A Project manager** having at least 10 years of experience with Engineering, Design, Construction, Installation and Commissioning & Testing Services for firefighting & fire protection projects for thermal power plants, gas plants or refineries. Documentary evidence should at least include the following: period of project execution, Contact information for Contractor and Client references and Contract Amounts.
 - 2. **A HSE officer** having experience with the execution of at least 3 projects concerning firefighting & fire protection or similar for gas plants.
 - 3. **A Piping Engineer/Mechanical Engineer** having at least 5 years of experience with Engineering and Design, supervising of firefighting & fire protection projects for gas plants or similar.
 - 4. **An Electrical Engineer/Fire protection Engineer** having at least 5 years of experience with Engineering and Design, supervising of fire protection projects including the fire detection and fire alarm system for gas plants or similar.

- 5. **A Civil Engineer** having at least 5 years of experience with planning, designing, and overseeing construction of structures and facilities as an engineering staff (*may also be from sub-contractor*).
- 6. **A Project Supervisor** having at least 5 years of experience with procurement, Engineering, Construction, Commissioning & Testing of firefighting & fire protection projects for gas plants or similar.
- 5. The Employer will award the contract to the qualified bidder whose offer is technically compliant and has the lowest evaluated price.
- 6.
